Sub: Violation of Punjab Procurement Rules 2014, Principal, Government College for Women Kahuta, District Rawalpindi's Re-Tender Notice for Miscellaneous Items.

Dear Sir,

This is with reference to Government College for Women Kahuta, District Rawalpindi's Re-Tender Notice, published in daily "Dawn" on 7th October, 2016. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per advertisement, "The Principal reserves the right to revoke/reject any or all tenders without assigning any reason thereof". However, it is not complying with PPRA 2014 Rule No. 35, which requires that reason should be communicated to bidders. Stated as under;

*35. Rejection of Bids :- (1) the procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.
(2) the procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
