**Sub: Violation of Punjab Procurement Rules 2014, District Emergency Officer,
The Punjab Emergency Service Rescue 1122, Multan's Tender Notice for
Procurement of Miscellaneous Items.**

Dear Sir,

This is with reference to Punjab Emergency Service Rescue 1122, Multan's Tender Notice, published in daily "Jang" on 5th September, 2017. It is observed that the advertisement is in violation of the Punjab Procurement Rules 2014.

As per the advertisement, "the quantity mentioned against above items can be increased/decreased by the department if required", whereas per rules, any change in tender conditions, specifications and quantity after the opening of the bid by procuring agency is not allowed under Rules. However according to PPR 2014, Rule No. 59 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

59. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works:

(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:

(iv) repeat orders not exceeding fifteen per cent of the original procurement;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- The quantity mentioned against above items can be increased/decreased by the department if required.
- The supplier firm must be registered with sales tax/income tax department and quote their GST/NTN numbers as well as provincial trade tax registration certificate.
- The rates must be offered according to details/instructions of tender inquiry.
- No bid shall be accepted after due date and time.
- Technical proposals shall be opened on 18-09-2017 at 02:00 PM while financial proposal shall be opened after 03 days on 21-09-2017 at 11:30 AM if applicable, in the presence of the bidders or their authorized representatives who choose to be present in the office of District Emergency Officer, Rescue 1122, Chowk Qazal, Multan by the committee.
- Bids not fulfilling the minimum requirement as stipulated in the bidding documents shall be declared non-responsive. Financial proposals of such non-responsive/qualified bidders shall be returned unopened.
- In case the tender proceedings are not done on the schedule date, the same shall be done on the next working day at the same place and time.
- Incomplete, conditional and bids without appropriate bid security shall not be considered.
- In case of any contradiction or discrepancy between this advertisement and the contents of bidding document, the contents of the bidding document shall prevail.
- Procurement shall be carried out as per Punjab Procurement Rules.

- Successful firms will deposit 5% performance guarantee of the total amount of supply order within a week after opening of tenders. Only their supply order will be issued.
