**Sub: Violation of Public Procurement Rules 2004, For Divisional Superintendent, Pakistan Railways, Quetta's Tender Notice for Supply of Common User Item.**

This is with reference to Pakistan Railways, Quetta's Tender Notice, published in daily "Jang" on 3<sup>rd</sup> August, 2019. It is observed that the advertisement is in violation of the PPRA Rules 2004.

As per advertisement, "The Competent Authority has the right to reject any or all offers without assigning any reason". It is not complying with PPRA Rules 2004, Rule No. 33, which requires that reason should be communicated to bidders. Stated as under:

*33. Rejection of bids:- (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Request for obtaining tender forms should be made only on letter head pad of the firm/company containing CNIC No. of the proprietor and copy of National Tax No. (NTN) (Active certificate in FBR) and Sales Tax Registration Certificate of the firm.

The competent authority has the right to reject any or all offers without assigning any reason.

No contractor/firm will be allowed to participate in tender process without the sample of items. All the samples of required items must be made in Pakistan. Acceptance of tenders will be made on the basis of quality/rates. No over writing will be allowed in rates both in words and figure.

The offer must be made valid for 90 days from the date of opening the tender, no terms and conditions from the firms would be acceptable.
