Sub: Violation of Public Procurement Rules 2004, Deputy Director, Project Directorate Sector 1-5, Capital Development Authority, Islamabad's Pre-Qualification Notice for Infrastructure Development.


This is with reference to Capital Development Authority, Islamabad's pre-qualification Notice, published in daily "Dawn" on 14th October, 2019. It is observed that the advertisement is in violation of the PPRA Rules 2004.

As per terms and condition No. 11 in the advertisement, "The Client reserves the right to reject any or applications without assigning any reason." It is a violation of Rule No.16 (4) of PPRA Rules 2004, as per the rule, the reason of rejection should be communicated to the applicants. Stated as under;

16. Pre-qualification process.- (4) The procuring agency shall communicate to those suppliers or contractors who have not been pre-qualified the reasons for not pre-qualifying them.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.
