Sub: Violation of Public Procurement Rules 2004, Section Officer, Planning and Development Department, Gilgit Baltistan's Tender Notice for Supply of IT/ Electronic Equipment.

This is with reference to P&D Department, Gilgit Baltistan's Tender Notice published in daily "The News" on 11th July, 2019. It is observed that the advertisement is in violation of the PPRA Rules 2004.

As per advertisement, only the bid opening date and time is mentioned whereas it should also include the bid submission date and time that shall be on the same day. Therefore the advertisement is in violation of PPRA Rules 2004, Rule 28(1). Stated as under;

28. Opening of bids. – (1) The date for opening of bids and the last date for the submission of bids shall be the same. Bids shall be opened at the time specified in the bidding documents. The bids shall be opened at least thirty minutes after the deadline for submission of bids.

It is mentioned in PPRA 'Tender Guidelines' on their website, that Tender Notice should contain closing date, time and place for receiving bids, as well as time of public opening of bids (Copy Attached).

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

TERMS AND CONDITIONS:-

1. Bid Security Call Deposit (4%) In shape of Bank Draft/Pay Order by a scheduled bank in the name of D.D.O Planning & Development Department Gilgit-Baltistan may be attached with the bidding/tender documents. No Tender without call deposit from a scheduled bank, will be accepted.
2. The successful bidder will have to submit 10% performance security in shape of CDR from scheduled bank within 7 days after bid opening.
3. The bidding should be processed in accordance with PPRA rule clause 36(b) on Single Stage-Two-Envelope basis.
4. The Contractor/Suppliers must be sole proprietor having his own complete setup (shop/store/workshop) containing adequate suppliers in Gilgit Town as well as at Islamabad/ authorized dealer/agent at Islamabad and he will be bound to supply demanded items at the office of Additional Chief Secretary (Dev) Planning & Development Department Gilgit-Baltistan.
5. Tender will be considered of those who have relevant experience manufactures or their authorized dealers and Government Contractors; otherwise the Tender/Bid will not be accepted.
6. Companies/Firms with pending liabilities, un-updated registration or blacklisted will not be eligible for participation in bidding process. (should provide non-black list affidavit)
7. Contractors/Suppliers may offer only the category of tender, in which he has complete set up (own shop, technical experts/staff, vast and past experience with documentary evidence).
8. Conditional, ambiguous & incomplete tenders shall not be accepted.
9. Bank statement for last 03 years, 03 years work Experience in relevant filed and Registration Certificate must be attached with bidding documents duly attested.
10. Any supplier who does not fulfill the required criteria as mentioned in the bidding documents will be rejected.
11. The Firm/ Dealer should quote the warranty period in original letter of company of each item on Invoice.
12. Delivery time will be maximum 15 days from date of issuance of supply order.
13. The tender will be opened in presence of bidders on 26th July, 2019 at the conference hall P&DD GB at sharp 11:00 am.

DESIRABLE MINIMUM INFORMATION TO BE PROVIDED IN TENDER NOTICE

1. Name of procuring agency
2. Tender number (for identification)
3. Procurement Title (indicating type and quantity)
4. Contact person (for seeking bidding documents)
5. Last date for obtaining bidding documents and its price (if any)
6. Closing time and date as well as place for receiving bids.
7. Time and Place of public opening of bids (Bids must be opened on the closing date)
8. Amount of bid security (%age of bid price)
9. Time period for performance of contract.
