**Sub: Violation of Public Procurement Rules 2004, Cantonment Executive Officer, Chaklala Cantonment Board, Chaklala's Tender Notice for Construction Works.**

This is with reference to Chaklala Cantonment Board, Chaklala's Tender Notice published in daily "Nawaiwaqt" on 12<sup>th</sup> July, 2019. It is observed that the advertisement is in violation of the PPRA Rules 2004.

As per advertisement, the bidding document fee is charged as PRs 10,000/- (non-refundable), which appears costly in light of the Public Procurement Rules 2004. Stated as under;

*25. Bidding documents. – (5) The procuring agency shall provide a set of bidding documents to any supplier or contractor, on request and subject to payment of price, if any.*

*Explanation - For the purpose of this sub-rule price means the cost of printing and providing the documents only.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
