**Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services
Rules 2014, Director of Works, University of Engineering and Technology, Peshawar's
Tender Notice for Electrification Works.**

This is with reference to UET, Peshawar's, Peshawar's Tender Notice, published in daily "Aaj" on 23rd July, 2019. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, the tender submission date is given as 06-08-2019, while the tender opening date is on 07-08-2019. Therefore, the advertisement is in violation of KPPRA Rules 2014, Rule No.37 (6). Stated as under;

37. Submission of bids and bid opening: — (6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- The bid documents including instruction to bidding can be downloaded upto one day prior to the opening date from UET Website www.uetpeshawar.edu.pk
- The bidder shall submit 2% call deposit of the estimated cost to the undersigned in original half an hour before closing date and time.
- The contractor bidders who quote their bids/rates more than 10 % below will submit additional security @ 8 % of the estimated cost as per "KPPRA amendment notification No. KPPRA/M&E/Estt:/1-5/2016 dated 06.06.2017 otherwise his bid will be considered as Non-responsive. In that case the 2nd lowest bidder will be considered accordingly
- E-bidding shall be done on "Above/Below" system on BoQ/Engineer Estimate, based on the MRS applicable.
- Electronic bids should be submitted electronically on or before the fixed date/time.
- All Taxes i.e Income Tax, Professional Tax, Sales Tax and Stamp Duty will be recovered as per directives of the Government issued from time to time.
- Any bidder who provides incorrect information shall stand disqualified and will be debarred.
