Subject:- Violation of Public Procurement Rules 2014, People's Primary Healthcare Initiative, Quetta's Tender Notice for purchase of Disposable/Surgical items.


Kindly refer to your letter No: TL19/1706/4A dated 17<sup>th</sup> June 2019 on the subject noted above wherein some observations on "Tender Notice" of PPHI-Balochistan published in daily Jang Quetta and daily Dawn Karachi on 13-06-2019 were raised with the plea that the same was in violation of the Public Procurement Rules 2014.

2. In this connection, it is to submit that PPHI-B is not a Public sector organization rather is an independent Company registered under section 42 of Companies Ordinance, 1984. The PPHI-B has its manual of operation with procurement rules. Public Procurement Rules 2014 are not applicable in case of PPHI-B. The official business in PPHI is dealt and disposed off on corporate model with efficiency and timely disposal with completion of codal formalities. PPHI-B has its Board of Directors (BoDs) to supervise the whole financial and administrative issues. The management seek approval of every such important issue from BoDs like any efficient and transparent organizations.

3. The observations pointed out in your above referred letter were examined by this organization. As per decision of the competent authority that "good practice in any rule/law should be followed", it was directed that corrigendum be issued by extending the last date for submission of bids accordingly.

4. In view of afore-mentioned "corrigendum" in order to make the tender notice of PPHI-B in line with the Public Procurement Rules 2014 was issued and the last date for submission of bids was extended from 20-6-2019 to 02-7-2019. The corrigendum was published in daily Jang Quetta and daily Dawn Karachi dated 20-6-2019 (copies enclosed).
