Sub: Violation of Sindh Public Procurement Rules 2010, District Health Officer, Office of District Health Officer, Sanghar's Tender Notice for Purchase of Machinery/ Equipment, Furniture/ Fixture and Transport for Construction.

This is with reference Office of District Health Officer, Sanghar's Tender Notice published in daily "Dawn" on 28th March, 2019. It is observed that the advertisement is in violation of the Sindh Public Procurement Rules 2010.

As per advertisement, the tender submission date is given as 11-04-2019 while the tender opening date is given as 12-04-2019. Therefore the advertisement is in violation of SPPRA 2010, Rule 41(1). Stated as under;

41. Opening of Bids: - (1) The date for opening of bids and the last date for the submission of bids shall be the same, as given in the bidding documents and in the Notice Inviting Tender;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 32(A), and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
