**Sub: Violation of Sindh Public Procurement Rules 2010, Executive Engineer,  
Highways Division, Jacobabad's Tender Notice for Installation of CCTV  
Cameras at Various Highly Sensitive Polling Stations.**

Dear Sir,

This is with reference to Highways Division, Jacobabad's Tender Notice, published in daily "Dawn" on 30<sup>th</sup> June, 2018. It is observed that the advertisement is in violation SPPRA 2010.

As per advertisement, 15 days of response time is not given and the last date for submission/ opening of tender is on 05-07-2018, which is 10 days short. It is a violation of SPPRA 2010, Rule No.18 (1).

*18. Response Time (1), the response time shall not be less than fifteen calendar days from the date of publication of Notice Inviting Tender in the newspapers or hoisting in the website, as the case may be, in case of National Competitive Bidding, and shall not be less than forty five days from the date of publication of Notice Inviting Tender in the newspapers or hoisting on the website, as provided in Rule 17 (6), in case of International Competitive Bidding;*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 32(A), and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- Eligibility criteria The Bidders who will provide following documents / information are eligible to participate as per SPPRA Rules 2010 amended 2017.
  - Registration with Pakistan Engineering Council (PEC) for the year 2018 in the relevant field of specification of work and to the extent of tender limit against work
  - Full Name, office address, Telephone, Fax & Cell Number, email and the organization with structure.
- The cost of price should be inclusive of taxes, installation, transportation charges, and all services prescribed and required by the Government / District Administration. And also the appointment of technical person to be handed over the full recording of all proceeding & responsible for installation, uninterrupted recording and service and un-installation of equipment & handing over to the concerned authority complete in all respect.
- The services of a technical person / focal person resources capable of installation and handling the above video surveillance system shall be continuously available in the polling station for ensuring uninterrupted recording of the proceedings.
- After the completion of Election process, the surveillance system shall be uninstalled by the technical person under proper certification.
- Registration with Income Tax Department (NTN Certificates)
- Vendor must be registered with SRB is required as per SPPRA Rule-46(1).
- The vendor must be done at least 50.0 (M) PKR.
- The vendor should be provide detail of current running systems.
- Undertaking on Affidavit that firm / agency are not involved in any litigation or abandoned any work in the department.
- The bidders should submit earnest money as shown against each item in shape of call deposit prepared from the scheduled bank in favour of the undersigned.
- Affidavit to the effect that the Firms / contractors have not been blacklisted previously by any executing agency.
- Affidavit with effect that all documents / particulars / information furnished are true & correct.
- In case of Firm, list of partners / Partnership Deed, giving full particulars of Directors / proprietors or others concerned along with Power of Attorney. In case of being sole proprietor such undertaking on stamp paper be furnished.
- In case of works costing below Rs. 4.000 (M) the conditions @ Sr. No. 3 will not be applicable.
