**Sub: Violation of Sindh Public Procurement Rules 2010, PSP Deputy Inspector General Police, Shaheed Benazirabad Range's Tender Notice for Supply of Miscellaneous Machinery Equipment.**

Dear Sir,

This is with reference to DIGP Office, Shaheed Benazirabad Range's Tender Notice, published in daily "Dawn" on 3<sup>rd</sup> May, 2018. It is observed that the advertisement is in violation SPPRA Rules 2010.

As per advertisement, Deputy Inspector General Police, Shaheed Benazirabad has restricted the bidders to supply items of specific brands only and has not added "**or equivalent**" with it, which is not allowed under SPPRA Rules 2010, Rule No. 13(1). Stated as under;

*13. Specifications(1) Specifications shall allow the widest possible competition and shall not favour any single contractor or supplier nor put others at a disadvantage. Specifications shall be generic and shall not include references to brand names, model numbers, catalogue numbers or similar classifications. However, if the procuring agency is convinced that the use of a reference to a brand name or a catalogue number is essential to complete an otherwise incomplete specification, such use or reference shall be qualified with the words "or equivalent".*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 32 (A), and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.

- Sealed tenders on prescribed proforma in duplicate along with 2% earnest money of the total bid in form of Pay Order (Payee's A/c in favour of DIGP SBA) on or before 15-05-2018 at 1400 hrs.
- Tenders shall be opened on 15-05-2018 at 1500 hours before the Procurement Committee and in presence of representatives of the bidders who choose to be present on the occasion.
- Only manufacturers, suppliers, authorized dealers and well reputed firms registered with FBR for Sales Tax, Income Tax & other related taxes are eligible to participate in the tenders (documentary proof is required).
- Only bids offered on the prescribed tender form issued by DIGP Shaheed Benazirabad shall be accepted.
- Conditional tender / application will not be entertained.
- The Procurement Committee reserves the right to increase or decrease the quantity of items as per SPPRA Rules.
- The Procurement Committee can cancel the bidding process at any time prior to the acceptance of a proposal as per provision of Rule 25(1) of SPP Rules 2010 (Amended 2017).
