

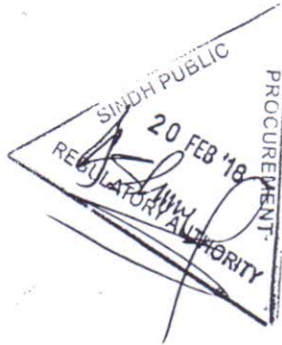


NOTIFICATION:
