for Carrying out the Operations & Maintenance.

Dear Sir,

This is with reference to STDC, Karachi's Tender Notices, published in daily "Dawn" on 8<sup>th</sup> May, 2016. It is observed that the advertisement is in violation of the Sindh Public Procurement Rules 2010.

As per advertisement, the Tender fee is given as PRs 15,000/-, which appears costly in light of SPPRA Rules 2010, Rule No. 20 (2). Stated as under;

*20. Provision of Bidding Documents (1) The procuring agency shall provide the bidding documents to all interested bidders in accordance with the procedures and requirements specified in the Notice Inviting Tender;*

*(2) The procuring agency may charge a fee for bidding documents, which shall not exceed the cost of preparation and printing.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 32(A), and with request to re-invite the tenders under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.
