Sub: Violation of Sindh Public Procurement Rules 2010, Section Officer/ DDO, Sindh Governor's Secretariat, Karachi's Tender Notice for Purchase of Miscellaneous Items.

Dear Sir,

This is with reference to Sindh Governor's Secretariat, Karachi's Tender Notice, published in daily "Dawn" on 10<sup>th</sup> May, 2016. It is observed that the advertisements are in violation of the Sindh Public Procurement Rules 2010.

As per advertisement, "The competent authority reserves the right to accept or reject any or all tenders without assigning any reason thereof", as per provision of SPPRA Rules, 2010." It is violation of Sindh Public Procurement Rules 2010, Rule No. 25. Stated as under;

*25. Cancellation of Bidding Process (4) The procuring agency shall, upon request by any of the bidders, communicate to such bidder, grounds for the cancellation of bidding process, but is not required to justify such grounds;*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 32(A), and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.
