
As per the advertisement, it is mentioned that, "The Project Director, BBSYDP, (L & F) PMU, Hyderabad/ Secretary of Purchase Committee BBSYDP, (L & F) reserves the right to reject any bid in whole or part in accordance with SPPRA Rules without assigning any reason". It is violation of Sindh Public Procurement Rules 2010, Rule No. 45. Stated as under;

45. Announcement of evaluation reports - Procuring agencies shall announce the results of bid evaluation in the form of a report giving reasons for acceptance or rejection of bids. The report shall be hoisted on website of the Authority and that of the procuring agency if its website exists and intimated to all the bidders at least seven (07) days prior to the award of contract.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 56, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
