The competent authority reserves the rights to reject any or all tenders as per provision of SPPRA Rules.

Unquote.

The word **without assigning any reason** was not mentioned anywhere in the NIT.

The copy of advertisement as received in SPPRA and hoisted on the website at serial No 23843. Copy is enclosed for your record, which shows clause 6 is the same as mentioned above. It is perhaps the proof reader of the Express newspaper who could not check the version of said clause in Urdu and the confusion arisen.

I am of opinion that there is no need of any re-invitation of tender and no any corrigendum is required.

A separate letter is also being sent to daily Express newspaper, to avoid such mistake in future.

He role of Transparency International to eliminate corruption is appreciated but it is regretted that this cancer is increasing day by day.
