Sub: Violation of Sindh Public Procurement Rules 2010, Medical Superintendent, Sindh Government Hospital, Qasimabad's Tender for Supply of Miscellaneous Items.

Dear Sir,

This is with reference to Sindh Government Hospital, Qasimabad's Tender Notice published in daily "Dawn" on 5<sup>th</sup> July, 2016. It is observed that the advertisement is in violation of the Sindh Public Procurement Rules 2010.

1. As per advertisement, "the Chairmen Purchase Committee reserves the right to make any change in the tender without assigning any reason thereof", whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However according to SPPRA 2010, Rule No. 16 (e) (i), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

*16. Alternate Methods of Procurements (1) A procuring agency may utilize following alternative methods of procurement of goods, services and works, namely:-*

*(e) Repeat Orders – means procurement of additional quantities of the item(s) from the original contractor or supplier, where, after the items originally envisaged for the project or scheme have been procured through open competitive bidding, and such additional quantities of the same item(s) of goods or works are needed to meet the requirements of the project or scheme;*

*Provided that;*

*(i) the cost of additional quantities of item(s) shall not exceed 15% of the original contract amount; and*

2. Also, the blank tender forms are made available to the bidders from 20-7-2016, i.e. after 16 days from the publishing of the notice. The rule "Response Time" includes purchase of bidding documents for the bidder from the date of publishing of advertisement. It is violation of SPPRA 2010, Rule No. 18(3). Stated as under;

*18. Response Time (3), Procuring Agency shall ensure that bidding documents are available to the interested bidders from the first day of publication of Notice Inviting Tender in the newspapers or hoisting on the website, as the case may be.*

3. Also, "the Chairmen Purchase Committee reserves the right to reject part or all tenders without assigning any reason thereof". It is violation of SPPRA 2010, Rule No. 25. Stated as under;

*25. Cancellation of Bidding Process (4) The procuring agency shall, upon request by any of the bidders, communicate to such bidder, grounds for the cancellation of bidding process, but is not required to justify such grounds;*



The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 32(A), and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
