Sub: Violation of Sindh Public Procurement Rules 2010, Assistant Executive Engineer,
Municipal Committee, Shikarpur's EOI Notice for Construction and Renovation Work.

This is with reference Municipal Committee, Shikarpur's EOI Notice published in daily "Dawn" on 12th February. It is observed that the advertisement is in violation of the Sindh Public Procurement Rules 2010.

As per the advertisement, "Chairman, Municipal Committee reserves the right to reject any or all EOIs without assigning any reason." However, it is not complying with SPPRA 2010, Rule No. 45 which requires that reason should be communicated to bidders. Stated as under;

45. Announcement of evaluation reports - Procuring agencies shall announce the results of bid evaluation in the form of a report giving reasons for acceptance or rejection of bids. The report shall be hoisted on website of the Authority and that of the procuring agency if its website exists and intimated to all the bidders at least three (03) days prior to the award of contract.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 32(A), and with request to re-invite the EOI under the prescribed procedures or issue a corrigendum and extend date accordingly.

Estimated Cost 750. Million Expression of Interest (EOI) is invited from reputed Architectural firms for providing Consultancy Services for following works in Shikarpur Municipal Hospital.

1. Renovation of ground floor and construction of 1st floor of 100 bedded existing Hospital: Approx area 22000 sq: ft: Scope for Consultancy Services would be as follows:

The scope includes services related to the disciplines of Architecture, site selection, Civil, Structural, Plumbing and Sanitation Engineering, Mechanical, Electrical, HVAC Engineering, Fire Protection, Site Utilities, IT and Telecommunication, Piped Medical Gases, Bio-Medical Waste Management Rain water harvesting, Interior Designing, Signage, landscaping etc ... for commencement of the construction as well as to occupy the building. To prepare detailed estimates technical specifications and all tender documents. To coordinate all pre-construction activities such as preparing schedules for activities, setting up design review, ensuring time bound preparation of tender documents, preparing status reports, assist in inviting tenders, evaluation of bids, and facilitate negotiations with contractors, preparing recommendation reports, and navigation of all pre/post construction activities.

Interested firms shall satisfy the following minimum criteria:

1. The applicants should have at least 10 years experience in handling above mentioned scope of work.
2. The applicant should have successfully completed similar/ relevant project work of the following magnitude in the last 5 years.
 - a) One work of Rs10.0 crores.

Or

- h) Two works, each of which is not less than 20 crores.

Mode of furnishing Expression of Interest (EOI)

- a) The EOI shall be submitted in the enclosed prescribed "Form A" duly supported with documentary evidence.
- b) Interested firms may get the application form from the office of the Chairman Municipal Committee Shikarpur.

c) All pages of the application should be stamped and signed by the applicant.

d) Sealed Expression of Interest (EOI) completed in all respect should be addressed to Chairman Municipal Committee Shikarpur, and duly superscribed "EOI for Architectural Consultancy Services". This should reach the office of Incharge Assistant Executive Engineer Municipal Committee Shikarpur.

e) EOIs shall be opened on 15th of February 2019 at the office of the Chairman Municipal Committee Shikarpur agencies may be present at the time of opening of EOI.

f) Names/name of shortlisted agencies / agency would be placed on the website www.mcshikarpur.gov.pk.

g) Merely, satisfying minimum criteria would not qualify for shortlisting. Municipal Committee on its discretion may inspect the sites and independently verify the particulars submitted by the firms. If during the evaluation or after appointment of the firms it gets revealed that the information furnished by the firms is/was incorrect, the firms shall be debarred from taking up works at Shikarpur Municipal Hospital. In such case the agreement shall be terminated without any compensation, irrespective of the services provided by the firms / firm till that point of time.

h) All the above works may be taken up simultaneously.

i) Chairman Municipal Committee reserves the right to reject any or all the EOIs without assigning any reason, in such eventuality the firm/firms shall not be compensated.
