**Sub: Violation of Sindh Public Procurement Rules 2010, Chairman, District Council,
Hyderabad's Tender Notices for Award of Contract of Sanitation Work.**

Dear Sir,

This is with reference to District Council, Hyderabad's Tender Notices, published in daily "Dawn" on 12th July, 2018. It is observed that the advertisements are in violation SPPRA 2010.

As per advertisement, "Authority reserves the right to accept/ reject any or all bids without assigning any reason thereof." However, it is not complying with Sindh Public Procurement Rules 2010, Rule No. 45 which requires that reason should be communicated to bidders. Stated as under;

45. Announcement of evaluation reports - Procuring agencies shall announce the results of bid evaluation in the form of a report giving reasons for acceptance or rejection of bids. The report shall be hoisted on website of the Authority and that of the procuring agency if its website exists and intimated to all the bidders at least seven (07) days prior to the award of contract.

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 32(A), and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.
