This is with reference to Agriculture Research Sindh, Tandojam's EOI Notice, published in daily "The News" on 11th November, 2018. It is observed that the advertisement is in violation SPPRA 2010.

No response time is mentioned for the submission of applications in the advertisement. It is a violation of SPPRA 2010, Rule No.18 (1). Stated as under;

18. Response Time (1), the response time shall not be less than fifteen calendar days from the date of publication of Notice Inviting Tender in the newspapers or hoisting in the website, as the case may be, in case of National Competitive Bidding, and shall not be less than forty five days from the date of publication of Notice Inviting Tender in the newspapers or hoisting on the website, as provided in Rule 17 (6), in case of International Competitive Bidding;

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 32(A), and with request to re-invite the EOI under the prescribed procedures or issue a corrigendum and extend date accordingly.

The applications are invited from the interested growers of Districts Qambar-Shahdadkot, Sukkur, Shaheed Benazirabad, Dadu, Tando Allahyar, Tando Muhammad Khan, Sanghar and Sujawal/Thatta to carryout remediation work on marginal land, under the ADP Scheme # 05 entitled "Remedial Improvement of Marginal Land through Effective Measures".

Methodology, Descriptions and Terms & Condition:

- A simple application addressed to the Director General, Agriculture Research Sindh along with copy of CNIC and form ---VII B (dully attested by revenue officer) should be submitted to district soil & water testing laboratory of concerned district within 30 days of publication of this EOI during office hours.
- The Director General, Agriculture Research Sindh will depute Assistant Agriculture Chemist, S&WTL and Assistant Soil Fertility Officer (ASFO) of concerned district to view the availability of Irrigation water, drainage, got soil samples for analyzing and report.
- The applications will be finalized on the basis of report submitted by Agriculture Chemist / ASFO of concerned district.
- Sixty percent of finalized area of each location will be remediated though project and forty percent by grower on his own expenses.
- The agreement on judicial paper will be obtained from grower.
- Land, labour, tractor, availability of water, fertilizer, manure, pesticides, POL, seed, and residence facility for Research fellow will be grower's responsibility.
- Incomplete applications will not be considered.
