Sub: Violation of Sindh Public Procurement Rules 2010, Deputy Commissioner, Office of Deputy Commissioner, Jamshoro's Tender Notice for Transportation of Wheat.

This is with reference to office of Deputy Commissioner, Jamshoro's Tender Notice, published in daily "Dawn" on 11th November, 2018. It is observed that the advertisement is in violation SPPRA 2010.

As per advertisement, "the Procurement Committee reserves the right to accept/ cancel or reject any or all the tenders without assigning any reason whatsoever." However, it is not complying with Sindh Public Procurement Rules 2010, Rule No. 45 which requires that reason should be communicated to bidders. Stated as under;

45. Announcement of evaluation reports - Procuring agencies shall announce the results of bid evaluation in the form of a report giving reasons for acceptance or rejection of bids. The report shall be hoisted on website of the Authority and that of the procuring agency if its website exists and intimated to all the bidders at least three (03) days prior to the award of contract.

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 32(A), and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
