
As per advertisement, "the tender documents are issued to bidders from 18-09-15". It is violation of Sindh Procurement Rules 2010, Rule No. 18(3). Stated as under;

18. Response Time (3), Procuring Agency shall ensure that bidding documents are available to the interested bidders from the first day of publication of Notice Inviting Tender in the newspapers or hoisting on the website, as the case may be.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 56, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
