**Sub: Violation of Sindh Public Procurement Rules 2010, DIGP/Administration for Additional Inspector General of Police, Karachi Range's Tender Notice for Supply of Furniture Articles.**

Dear Sir,

This is with reference to Police Department, Karachi Range's Tender Notice, published in daily "Dawn" on 17<sup>th</sup> March, 2017. It is observed that the advertisement is in violation Sindh Procurement Rules 2010.

As per advertisement, "Police Department reserves the right to increase or decrease the quantity of items without assigning any reason", whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However according to SPPRA Rules 2010, Rule No. 16 (e), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

*16. Alternate Methods of Procurements (1) A procuring agency may utilize following alternative methods of procurement of goods, services and works, namely:-*

*(e) Repeat Orders – means procurement of additional quantities of the item(s) from the original contractor or supplier, where, after the items originally envisaged for the project or scheme have been procured through open competitive bidding, and such additional quantities of the same item(s) of goods or works are needed to meet the requirements of the project or scheme;*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 32(A), and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.




Each envelope shall contain separately sealed financial proposal and technical proposal. Envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion.		
02. Interested Manufacturers, Suppliers, Authorized dealer & well reputed firms may obtain the tender documents along with tender fees Rs. 1,000/- each item for the supply of above Furniture item from the office of the Addl: IGP Karachi, 3rd Floor Account Branch, Karachi Police Office (KPO) near P.S. Saddar Shakra-e-Faisal, Karachi by submitting an application on their letterhead along with tender fees from the date of publication of the tender upto <b>04.04.2017</b> during office hours on working days.		
03. Sealed tenders on prescribed proforma in duplicate along with 2% earnest money of the total bid in the form of Pay Order (Payee's A/C in favour of DIGP / Admin) should be dropped in the tender box kept in office of the Addl: IGP Karachi, 4th Floor Conference Room, Karachi Police Office (KPO) near P.S. Saddar Shakra-e-Faisal, Karachi on or before <b>05.04.2017</b> at <b>1400 hours</b> .		
04. The tender shall be opened on <b>05.04.2017</b> at <b>1430 hours</b> in presence of Procurement Committee and in presence of representatives of bidders who choose to be present on the occasion in the Committee Room of Addl: IGP Karachi, 4th Floor Karachi Police Office (KPO) near P.S. Saddar Shakra-e-Faisal, Karachi.		
05. Only Manufacturers, Suppliers, Authorized dealers and well reputed firms registered with Income Tax and Sales Tax Department are eligible to participate in the tenders (Documentary proof required).		
06. Only bids offered on the prescribed tender form issued by the Police Department shall be accepted. However, additional sheets may be attached, if required.		
07. Bidders should submit their bid/bids along with sample / samples. Without samples bids will not be entertained.		
08. Conditional Tender/application will not be entertained.		
09. Police Department reserves the right to increase or decrease the quantity of items without assigning any reason.		
10. Competent authority can cancel the bidding process at any time prior to the acceptance of a proposal as per provision of Rule-25(1) of SPP-Rules. 2010 (Amended 2013).
