

Kindly refer to your letter NO.QUEST/PD/SCAD/SUKKUR/263/2015 dated 13.11.2015; the undersigned is directed to convey observations of this Authority as under:

- i. Bidding documents of subject tender notice received in this Authority after opening of bids i.e. on 16.11.2015. It is mandatory for procuring agency to furnish bid documents along with tender notice for hosting on Authority's website in terms of Rules-21(4) & 24(2) of SPP Rules, 2010 (Amended 2013); hence, said rules have been violated in the instant case. *Procuring agency is informed here that no any letter of dated 26.10.2015 was received to this Authority as claimed in your above referred letter.*
- ii. In case of any change in tender notice, procuring agency is required to issue corrigendum in terms of Rule-21(2) read with Clause-4.10 of Procurement Regulation of SPPRA by keeping in view the following points, which in the instant case have not been complied:
 - a. notice of corrigendum is issued prior to expiry date of submission of bids or at least published within 3 days of expiry date/opening date and hoisting on the same date.
 - b. notice is to be advertized in a manner similar to the original advertisement. *Affixing of corrigendum on notice board of office of the procuring agency cannot a substitute to the requirement of publication in newspaper or hoisting on SPPRA website as the case may be.*
 - c. in case of material deviation, it is necessary to provide a minimum response period of fifteen days which will be counted from the date of publication/hoisting of such corrigendum on website.
- iii. Procuring agency is required to furnish copies of notification of procurement committee constituted in terms of Rules-07 & 08, annual procurement plan on

standard format in terms of Rules-11 & 12, and notification of complaint redressal committee constituted in terms of Rule-31 of SPP Rules, 2010 (Amended 2013). Such documents should be furnished with each tender notice in order to ensure further procurement procedure and availability of item in procurement plan.

- iv. Reply of this Authority's letter of even number dated 20.11.2015 is still awaited.
02. Procuring agency is, therefore, advised to furnish requisite documents as well as clarification/ justification with regard to the above observations, at the earliest.
03. It is relevant to mention that it is sole responsibility of the procuring agency to follow rules in letter and spirit.
