Sub: Violation of Sindh Public Procurement Rules 2010, Medical Superintendent, Taluka Hospital, Thano Bula Khan's Tender Notices for Purchase of Miscellaneous Items.

This is with reference to Taluka Hospital, Thano Bula Khan's Tender Notice, published in daily "Dawn" on 14th February, 2019. It is observed that the advertisement is in violation SPPRA 2010.

1. As per advertisement, "the Procurement Committee reserves the right to make any changes in the tender without assigning any reason thereof", whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However according to SPPRA Rules 2010, Rule No. 16 (e), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

***16. Alternate Methods of Procurements** (1) A procuring agency may utilize following alternative methods of procurement of goods, services and works, namely:-*

(e) Repeat Orders – means procurement of additional quantities of the item(s) from the original contractor or supplier, where, after the items originally envisaged for the project or scheme have been procured through open competitive bidding, and such additional quantities of the same item(s) of goods or works are needed to meet the requirements of the project or scheme;

2. Also, "The Procurement Committee reserves the right to reject any part or all tenders without assigning any reason thereof." However, it is not complying with SPPRA Rules 2010, Rule No. 45 which requires that reason should be communicated to bidders. Stated as under;

***45. Announcement of evaluation reports** - Procuring agencies shall announce the results of bid evaluation in the form of a report giving reasons for acceptance or rejection of bids. The report shall be hoisted on website of the Authority and that of the procuring agency if its website exists and intimated to all the bidders at least seven (07) days prior to the award of contract.*



The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 32(A), and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
