I am directed to say that the department has made three abortive attempts, in terms of NIT, for fumigation as following:-


- i)- 18.05.2018 (NIT)
- ii)- 07.09.2018 (NIT)
- iii)- 04.12.2018 (NIT)

02. Fumigation has already been considerably delayed which otherwise should have materialized by May / June 2018 and there is cogent apprehension of weevilization of Government stocks worth billions of Rupees on large scale

03. Because of delay in fumigation signs / symptoms of weevilization have already surfaced especially in Government Godowns in Karachi. Rest of the Sindh is also vulnerable to said signs / symptoms.

04. Competent authority, on a note sheet moved by your office dated 08.01.2019 has been pleased to approve as following -

"As per enabling Rule 19(1) of SPPRA Rule, 2010 (amended upto date) may be called by stipulating of 07 (seven) days in NIT instead of 15 (fifteen) days contrary to required of rule 18 of said rules.
