**Sub: Violation of Sindh Public Procurement Rules 2010, Acting Director, National
Institute of Child Health (NICH), Karachi's Tender Notice for Purchase of
Miscellaneous Items.**

Dear Sir,

This is with reference to (NICH), Karachi's Tender Notice, published in daily "Dawn" on 19th Aug, 2019. It is observed that the advertisement is in violation of the SPPRA 2010.

As per the advertisement, it is mentioned that tenders shall reach within fourteen (15) days from the date of printing of the advertisement, which makes it 02-09-2019, while the opening date of bids is given as 05-09-2019. Therefore the advertisement is in violation of SPPRA 2010, Rule 41(1). Stated as under;

41. Opening of Bids: - (1) The date for opening of bids and the last date for the submission of bids shall be the same, as given in the bidding documents and in the Notice Inviting Tender;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 32(A), and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
