As per advertisement, "The Procurement committee reserves the right to accept or reject any bid without assigning any reasons". It is violation of Sindh Public Procurement Rules 2010, Rule No. 25. Stated as under;

*25. Cancellation of Bidding Process (4) The procuring agency shall, upon request by any of the bidders, communicate to such bidder, grounds for the cancellation of bidding process, but is not required to justify such grounds;*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 32(A), and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
