**Subject: NIT REF NO.TC/G-55/374 DATED 18.03.2019 – PROCUREMENT OF CONSTRUCTION WORKS.**

The undersigned is directed to refer to the subject notice inviting tender posted on Authority's PPMS website at ID # T00873-18-0005 dated 26.03.2019 and to observe that the procuring agency had failed to rectify and furnish compliance against the following infirmities/ observations (reproduced below) as communicated on 08.04.19 by this Authority against above referred NIT:

- 1.1. Eligibility criteria mentioned in the NIT was ambiguous, as minimum years of experience and turnover required for bidder(s) to qualify was not mentioned as required under Rule-46(1) of SPP Rules, 2010 (Amended 2019);
- 1.2. The condition mentioned in the NIT i.e. any addition or deletion can be made by the undersigned, was required to be qualified by the words 'as per provisions of SPP Rules, 2010 (Amended 2019);
- 1.3. NIT published in leading dailies of English and Sindhi languages in terms of Rule-17(1A) & (2) was required to be posted on the Authority's website;
- 1.4. NIT consisted of 5-works whereas the procuring agency posted bid documents for only one work, which was also incomplete, on the Authority's website; the procuring agency was required to post complete and standard bid documents for all works on the Authority's website in terms of Rules-21(1), (3) & (4) of SPP Rules, 2010 (Amended 2019).

2. Since the timelines to rectify above infirmities/ observations, particularly listed at 1.1 & 1.4 above, have elapsed; therefore, it is advisable to proceed under Rules-25 & 26 read in conjunction with Rule-23(2) of SPP Rules, 2010 (Amended Up to date) otherwise the matter will be referred to the sub-committee of SPPRA Board for its decision.
