**Sub: Violation of Sindh Public Procurement Rules 2010, Director Marketing, Karachi Metropolitan Corporation Public Housing Scheme KDA Wing, Karachi's EOI Notice for Providing Residential Units (flats) on Ownership Basis to its Employees of Grade I to Grade 20.**

Dear Sir,

This is with reference KMC Public Housing Scheme KDA Wing, Karachi's EOI, Karachi's Tender Notice, published in daily "Dawn" on 1<sup>st</sup> October, 2014. It is observed that the advertisement is in violation Sindh Procurement Rules 2010.

1. As per the advertisement, no information regarding issuance of tender documents is given for bidders, which is violation of Sindh Public Procurement Rules 2010, Rule No. 20 (1). The Rule is quoted below for your information:

*20. Provision of Bidding Documents (1) The procuring agency shall provide the bidding documents to all interested bidders in accordance with the procedures and requirements specified in the Notice Inviting Tender;*

2. Also, no Expression of Interest documents are issued for a bidder, that include criteria for short listing; which is mandatory requirement of Sindh Procurement Rules 2010, Rule No. 73 (2) (d). The Rule is quoted below for your reference:

**73. Request for Expression of Interest**

*(2) Request for Expression of Interest shall contain the following information:*

- (a) name and address of procuring agency;*
- (b) appropriate description of the assignment providing scope of the intellectual and professional services required;*
- (c) deadline and place of the submission of Request for Expression of Interests;*
- (d) criteria for short listing; and*
- (e) any other information that the procuring agency may deem appropriate to disseminate at this stage.*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 56, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
