This is with reference to Right Bank Tubewell Division, Ratodero's Quotation Notice, published in daily "The News" on 15<sup>th</sup> July, 2015. It is observed that the advertisement is in violation of the Sindh Public Procurement Rules 2010.

As per the advertisement 15 days of response time is not given and the last date of submission of tender is given on 21-07-2015 which is 8 days short. It is a violation of Sindh Public Procurement Rules 2010, Rule No 18. The Rule is quoted below for your reference;

*18. Response Time (1), the response time shall not be less than fifteen calendar days from the date of publication of Notice Inviting Tender in the newspapers or hoisting in the website, as the case may be, in case of National Competitive Bidding, and shall not be less than forty five days from the date of publication of Notice Inviting Tender in the newspapers or hoisting on the website, as provided in Rule 17 (6), in case of International Competitive Bidding;*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 56, and with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.
