Dear Sir,

This is with reference to Deputy Commissioner, Sukkur's Tender Notice, published in daily "Dawn" on 18<sup>th</sup> May, 2015. It is observed that the advertisement is in violation SPPRA Rules 2010.

As per the advertisement, it is mentioned that, "The competent authority reserves the right to reject any or all tenders without assigning any reason thereof as per provision of SPPRA Rules", which is violation of Sindh Public Procurement Rules 2010, Rule No. 45. The Rule is quoted below for your reference;

*45. Announcement of evaluation reports - Procuring agencies shall announce the results of bid evaluation in the form of a report giving reasons for acceptance or rejection of bids. The report shall be hoisted on website of the Authority and that of the procuring agency if its website exists and intimated to all the bidders at least seven (07) days prior to the award of contract.*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 56, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
