25. Cancellation of Bidding Process (4) The procuring agency shall, upon request by any of the bidders, communicate to such bidder, grounds for the cancellation of bidding process, but is not required to justify such grounds;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 32(A), and with request to re-invite the EOI under the prescribed procedures or issue a corrigendum and extend date accordingly.

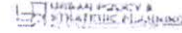
