SUBJECT: NIT NO. SKP/G-66/1415/2015 DATED 15.06.2015 (Sr# 24588).

I am directed to refer to subject NIT and to state that this Authority has observed as following;

- i. The procuring agency (P.A) is required to furnish the standard bidding documents for hoisting on Authority's website as well as on the website of its own department in terms of Rule-21(4) of SPP Rules, 2010, so that the interested bidders are facilitated to access bids in terms of Rule-24(2) of SPP Rules, 2010 (amended 2013).
- ii. The term **Quotation** mentioned in the Notice, which is not covered under SPP Rules, 2010 (Amended 2013). The correct term for all procurement over rupees one Lac is Notice Inviting Tender (NIT), which may be used. Corrigendum is required.
- iii. The P.A has mentioned "**other items**" in the NIT, which is procured through the subject notice. The list of same works is required.
- iv. The P.A is required to furnish published copy of NIT in leading English, Urdu and Sindhi language newspapers in terms of Rule-17(1A) & (2) of SPP Rules, 2010 (amended 2013).
- v. The PA mentioned in the NIT that bidding documents shall be provided on prior production of call deposit, which should be rephrased as under:
"Tender documents shall be issued to all interested bidders and same can also be downloaded from SPPRA's website". **Corrigendum is required.**
- vi. The procuring agency shall require the bidders to furnish a bid security not below one percent and not exceeding five percent of the bid price in terms of Rule-37 of the SPP Rules, 2010 (amended 2013), instead of mentioning call deposit as Rs. 50,000/-
- vii. In case of second attempt / un-responded bids, the minimum time of 15 days for issuance of bidding documents be provided as required under Rule-18 read with Rule-2(1)(iv)(eee) of SPP Rules, 2010 and mention schedule (date & time) for submission & opening of bids in terms of Rule-17(3)(c) read with Rule-41(1)&(3) of SPP Rules, 2010. Corrigendum is required.

- viii. The copy of Notification of Procurement Committee constituted in terms of Rule-07 & 8 of SPP Rules, 2010 is required.
- ix. The Annual Procurement Plan for the F.Y of 2014-15 on the prescribed proforma in terms of Rule-11 of SPP Rules, 2010 is required.

2. It is, therefore, advised to furnish all the above mentioned documents and clarification/ justification at the earliest.
