

SUBJECT: REJECTION OF BID, MALAFIEDE BLACKLISTING OF M/S AMMAR MEDICAL STORE & SUPPLIERS.
Reference: Tender for supply of Drugs and Medicines (15% L.P) for financial year 2018-19 and letter No LUH-Ger-Br 35693/96 dated 1.8.2018

Dear Sir,

We have been participating in tender business for last 10 years following all norms of transparency and professionalism. Unfortunately since last three years we are kept out of business with ill intentions and favoring just these companies i.e i- M/s Medilog Sales & Services ii- M/s A to Zee International (The both firms are belongs same family and the owner of both firms are real brothers and these are not proper medical stores also).

Recently we participated in the tender for Local Purchase of Drugs and Medicines on Daily Emergency Basis (24/7 basis) dated 17-07-2018 but we were rejected on non compliance prerequisite that is NO Professional Certificate (Copy of the letter is enclosed). When we wrote the Medical superintendent that required document is already in the offer /bid and had sent them copy of the same for ready reference. Instead of resolving our problem through CRC, Purchasing Agency called upon us to explain why we were blacklisted and still hosted on SPPRA website.

Sir, our firm was ill intentionally declared blacklisted and sent by then MS Liaquat Univerisity Hospital Hyderabad to SPPRA for hosting; we thus filed petition in Honorable Sindh High Court against his decision meantime Mr. A.Sattar Jatoh (who is still working in same place as Director Admin & Finance) approached to us and conveyed that M.S is reprimanding for his ill intention and had requested to withdraw the petition consequently our firm shall be considered in competition we withdrew the petition and participated in the tender our bid however was rejected on technical reason but same letter appreciated our participation and encouraged to participate in future (Copy of the letter enclosed).

Sir that was clear indication that our blacklisting was withdrawn and we were allowed to participate. It is pertinent to mention that this time also our bid was accepted and evaluated by the procurement committee which includes Mr. A.Sattar Jatoh. Though was rejected on wrong assumption that we did not fulfill the criteria but when we approached and gave proof that our bid is compliant bid and is responsive..

Sir when Purchasing Agency felt that they cannot reject our compliant / responsive bid, they has sent us explanation letter to harass and pressurize us not to pursue our bid. It is sole responsibility of PA to write to SPPRA for withdrawal of our firm from blacklist.


