Sub: Violation of Sindh Public Procurement Rules 2010, Mehran University of Engineering & Technology MUET, Shaheed Zulfiqar Ali Bhutto Campus, Khairpur Mirs' Tender Notice for Supply of Items, Binding and Printing Material and Providing of Hygiene and Quality Food in Canteens.

Dear Sir,

This is with reference to MUET, Shaheed Zulfiqar Ali Bhutto Campus, Khairpur Mirs' Tender Notice, published in daily "The News" on 19<sup>th</sup> March, 2015. It is observed that the advertisement is in violation of the Sindh Public Procurement Rules 2010.

As per advertisement, the tender is issued after 7 days, that is, from 26.3.2015 to 13.4.2015 from the publication of the tender notice, which is violation of SPPRA 2010, Rule 18 (3). The Rule is quoted below for your reference;

*18. Response Time:- (3) Procuring Agency shall ensure that bidding documents are available to the interested bidders from the first day of publication of Notice Inviting Tender in the newspapers or hoisting on the website, as the case may be.*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 56, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
