On the recommendations of Procurement Committee-I, the Sindh Solid Waste Management Board (SSWMB) has been pleased to accept your bid amounting to **Rs. 375/-** per ton for transportation / lifting of garbage (solid waste) from GTS of DMC East to Landfill Site for above tender as per details given below. (As per estimated 1400 Tons of garbage generated in DMC (East) per day, the approximate amount of annual contract is **Rs. 191,625,000/-** Rupees One hundred ninety one million six hundred and twenty five thousand only)

2. Based on your execution of the contract agreement and submission of performance security for "Transportation / Lifting of Garbage (Solid Waste) from Garbage Transfer Station (GTS) DMC East to Landfill Site", you are directed to start the work forthwith and carryout the same during stipulated time period as mentioned in Bidding Documents as agreed / offered / accepted by your company in the bid along with the terms and conditions.

3. The Deputy Director (GTS) East, SSWMB will issue necessary instructions on day-to-day basis for carrying out the works / services awarded to you.

4. You are further directed to take the following measure at the site during execution:

- i. Professional expert should be present at site along with your site supervisor till the completion of work.
- ii. All safety measure arrangement should be taken at site to avoid any mishap.
- iii. All other terms would be same as per agreement and terms and conditions of the contract mentioned in the BoQ of Bidding Document.
- iv. Works completion program within stipulated time shall be submitted within 04 (Four) days of receipt of this work order.
- v. A proper display board with pre-approved text by competent authority i.e. Director / Deputy Director (GTS), Sindh Solid Waste Management Board Karachi should be installed and maintained by the contractor throughout the contractual period.
- vi. In case of any un-necessary delay in execution of work, penalty shall be imposed on the contractor as per SPPRA rules / terms and conditions of the contract.
