Sub: Violation of Sindh Public Procurement Rules 2010, Superintendent Engineer, Rohri Canal Division, Hyderabad's Tender Notice for Consultants.

Dear Sir,

This is with reference to Rohri Canal Division, Hyderabad's Tender Notice, published in daily "Dawn" on 20th November, 2015. It is observed that the advertisement is in violation of the Sindh Public Procurement Rules 2010.

As per advertisement, "it is mentioned that proposal sealed shall reach the office of the undersigned not late than fifteen 15 days after the publication of the advertisement, without mentioning the time of submission and date and time for opening of tender that shall also be on the same day". It is violation of Sindh Public Procurement Rules 2010, Rule 24. Stated as under;

24. Submission of Bids (1) Bids shall be submitted on the place, date and time and in the manner specified in the tender notice and bidding documents and any bid submitted late due to any reason whatsoever, shall not be considered by the procurement committee;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 56, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
