This is with reference to Municipal Committee, Gambat's Tender Notice, published in daily "The Nation" on 25th May, 2017. It is observed that the advertisement is in violation Sindh Procurement Rules 2010.

As per advertisement, the last date for submission of tender is given as 06-06-17, while the opening date for tender is given as 08-06-17. It is violation of SPPRA 2010, Rule 41(1). Stated as under;

41. Opening of Bids: - (1) The date for opening of bids and the last date for the submission of bids shall be the same, as given in the bidding documents and in the Notice Inviting Tender;

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 32(A), and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
