Dear Sir,

This is with reference to Shaheed Mohtarma Benazir Bhutto, Sindh University, Staff Housing Scheme, Jamshoro's Tender Notice, published in daily "Dawn" on 23rd January, 2016. It is observed that the advertisement is in violation of the Sindh Public Procurement Rules 2010.

As per advertisement, "Work & Development Committee of SMBBSUSHS has the right to accept or reject all or any bids at any stage without assigning any reason thereof". It is violation of Sindh Public Procurement Rules 2010, Rule No. 45. Stated as under;

45. Announcement of evaluation reports - Procuring agencies shall announce the results of bid evaluation in the form of a report giving reasons for acceptance or rejection of bids. The report shall be hoisted on website of the Authority and that of the procuring agency if its website exists and intimated to all the bidders at least seven (07) days prior to the award of contract.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 32(A), and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
