Sub: Complaint against Scheme NIT No: XEN (EWD) AB/TC/140, Advertised on SPPRA Website by Executive Engineer, Education Works Division, Hyderabad on 08-08-2018 on the Subject of Non-Issuance of Tender Documents.

Dear Sir,

Transparency International Pakistan has received a complaint of Scheme NIT No: XEN (EWD) AB/TC/140, Advertised on SPPRA Website by Executive Engineer, Education Works Division, Hyderabad on 08-08-2018 on the subject of non-issuance of tender documents. The complaint (annexure) is enclosed for your ready reference.

The Complainant has alleged that the relevant department is habitual of non-issuance of tender documents to the interested contractors and award work to his favorite contractors, violating the SPPRA rules and regulations.

TIP's observation is that, if the allegation is correct, it is a violation of Sindh Procurement Rules 2010, by the Executive Engineer, Education Works Division, Hyderabad for not issuing its tender documents to interested bidder, which is violation of Sindh Procurement Rules 2010, Amendments dated 8th October 2013, Rule 21(4) and Rule 24 (2), quoted below:

Sindh Procurement Rules 2010 Amendments made in Rule 21 sub-rule (4):-

"Rule 21(4) All procuring agencies shall hoist the bidding documents on Authority's website as well as on the website of procuring Agency, in case the procuring agency has its own website."

Sindh Procurement Rules 2010 Amendments made in Rule 24 sub-rule (2):-

"Rule 24 (2) the Bidders may submit bids on the bidding documents issued by the procuring agency or downloaded from the Authority's website along with tender fee if any by mail or by hand."

NAB has also directed vide its letter No 5-2 (75) Pre/ A & P/ NABHQ/ 2013 dated 8th January (Copy encl), all procuring agencies should make available the bidding or prequalification documents and other related communication in downloaded format, for any interested bidder or party, at their website to use these documents for submitting bid(s) with admissible tender fee, if any, paid in bank as prescribed by procuring agency. NAB has also declared mis-procurement as liable for cognizance by NAB under relevant section of NAO 1999.

Chief Secretary, Government of Sindh, Karachi is requested to kindly look into the complaint and if found genuine take necessary action against all those officers involved in corrupt practices.
