Dear Sir,

This is with reference to Shah Abdul Latif University, Khairpur's Quotation Notice, published in daily "The News" on 27th January, 2016. It is observed that the advertisement is in violation of the Sindh Public Procurement Rules 2010.

As per advertisement, "The University reserves the right to cancel the bid without any reason". It is violation of Sindh Public Procurement Rules 2010, Rule No. 25. Stated as under;

25. Cancellation of Bidding Process (4) The procuring agency shall, upon request by any of the bidders, communicate to such bidder, grounds for the cancellation of bidding process, but is not required to justify such grounds;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 32(A), and with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.
