Sub: Violation of Sindh Public Procurement Rules 2010, Medical Superintendent, Sindh Government Hospital, Qasimabad, Hyderabad's Tender Notice for Supply of Miscellaneous Items.

Dear Sir,

This is with reference to Sindh Government Hospital, Qasimabad, Hyderabad's Tender Notice, published in daily "Dawn" on 24th July, 2015. It is observed that the advertisement is in violation of the Sindh Public Procurement Rules 2010.

1. As per advertisement, the tender documents are issued to bidders from 20-08-15, which is violation of Sindh Procurement Rules 2010, Rule No. 18(3). Stated as under;

18. Response Time (3), Procuring Agency shall ensure that bidding documents are available to the interested bidders from the first day of publication of Notice Inviting Tender in the newspapers or hoisting on the website, as the case may be.

2. Also it is stated that, "The Chairman Purchase Committee reserves the right to reject a part or all tenders without assigning any reason thereof", which violation of Sindh Public Procurement Rules 2010, Rule No. 45. Stated as under;

45. Announcement of evaluation reports - Procuring agencies shall announce the results of bid evaluation in the form of a report giving reasons for acceptance or rejection of bids. The report shall be hoisted on website of the Authority and that of the procuring agency if its website exists and intimated to all the bidders at least seven (07) days prior to the award of contract.

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 56, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.
