Sub: Violation of Sindh Public Procurement Rules 2010, Assistant Commissioner, Mines Labour Welfare Commissioner, Karachi's Tender Notice for Miscellaneous Works.

Dear Sir,

This is with reference to Mines Labour Welfare Commissioner, Karachi's Tender Notice, published in daily "Dawn" on 28th March, 2018. It is observed that the advertisement is in violation Sindh Procurement Rules 2010.

As per advertisement, "the Purchase Committee reserves the right to increase or decrease the quantity or include or delete any item from the tender document", whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However according to SPPRA Rules 2010, Rule No. 16 (e), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

16. Alternate Methods of Procurements (1) A procuring agency may utilize following alternative methods of procurement of goods, services and works, namely:-

(e) Repeat Orders – means procurement of additional quantities of the item(s) from the original contractor or supplier, where, after the items originally envisaged for the project or scheme have been procured through open competitive bidding, and such additional quantities of the same item(s) of goods or works are needed to meet the requirements of the project or scheme;

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 32 (A), and with request to re-invite the notice under the prescribed procedures or issue a corrigendum and extend date accordingly.
