This is with reference to Karachi Metropolitan Corporation, Karachi's Tender Notice, published in daily "Dawn" on 25th August, 2015. It is observed that the advertisement is in violation of the Sindh Public Procurement Rules 2010.

As per advertisement, it is stated that, "KMC reserves the right to reject any or all tenders without assigning any reason thereof in accordance with the Sindh Public Procurement Rules 2010", which violation of Sindh Public Procurement Rules 2010, Rule No. 45. Stated as under;

45. Announcement of evaluation reports - Procuring agencies shall announce the results of bid evaluation in the form of a report giving reasons for acceptance or rejection of bids. The report shall be hoisted on website of the Authority and that of the procuring agency if its website exists and intimated to all the bidders at least seven (07) days prior to the award of contract.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 56, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
