Sub: Violation of Sindh Public Procurement Rules 2010, Deputy Inspector General of Police,
Larkana Range's Tender Notice for Construction of Facilitation Centers.

Dear Sir,

This is with reference to Deputy Inspector General of Police, Larkana Range's Tender Notice, published in daily "Dawn" on 28th October, 2016. It is observed that the advertisement is in violation of the Sindh Public Procurement Rules 2010.

As per advertisement, the cost of bidding document is given as PRs 15,000/-, which appears costly in light of SPPRA Rules 2010, Rule No. 20 (2). Stated as under;

20. Provision of Bidding Documents (1) The procuring agency shall provide the bidding documents to all interested bidders in accordance with the procedures and requirements specified in the Notice Inviting Tender;

(2) The procuring agency may charge a fee for bidding documents, which shall not exceed the cost of preparation and printing.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 32(A), and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.
