

Minimum Qualification Criteria:

- i) List of similar assignment with cost (at least two projects) undertaken over the past (03) years.
 - ii) Detail of equipment, machinery, main power & owned transport/ leased/ higher by firm/ contractor
 - iii) Financial statement (summary) from bank and income tax written for the last 03 years.
 - iv) Affidavit that firm has never been black listed.
4. Earnest Money equal 2 % of the offered amount should be enclosed along with tender in shape of pay order from any schedule bank in the favors of Municipal Committee Matli.
 5. In case of opening date is declared as public holiday by the Government, the next official working day shall be deemed to be the date for submission and opening of tenders at the same time.
 6. Conditional tender will be not accepted.
 7. Tender in unsealed covers will not be accepted.
 8. The total bid as well as the rates in terms must be filled in both in figures and words, and in case of any correction in quantity and description of items is made by Contractor himself, then each correction must be initialed by contractor.
