Sub: Violation of Sindh Public Procurement Rules 2010, Senior Superintendent of Police, District Central, Karachi's Tender Notice for Repair/ Renovation Works of Police Stations.

Dear Sir,

This is with reference to District Central Police, Karachi's Tender Notice, published in daily "Dawn" on 4th April, 2016. It is observed that the advertisement is in violation Sindh Procurement Rules 2010.

1. As per advertisement, tender documents can be obtain from 1st April, 2016 till 10th April, 2016, which means bidding documents are not available for the bidders for 15 days. The rule "Response Time" includes purchase of bidding documents for the bidder from the date of publishing of advertisement till the date of submission of bids. It is violation of SPPRA 2010, Rule No. 18(1). Stated as under;

18. Response Time (1), the response time shall not be less than fifteen calendar days from the date of publication of Notice Inviting Tender in the newspapers or hoisting in the website, as the case may be, in case of National Competitive Bidding, and shall not be less than forty five days from the date of publication of Notice Inviting Tender in the newspapers or hoisting on the website, as provided in Rule 17 (6), in case of International Competitive Bidding;

2. Also, there is an ambiguity; it is mentioned that bids should be submitted/ dropped up to 18-04-16 and bid shall be opened on the same day (11-04-16), which is incorrect and is creating confusion about the correct date. It is violation of SPPRA 2010, Rule 41(1). Stated as under;

41. Opening of Bids: - (1) The date for opening of bids and the last date for the submission of bids shall be the same, as given in the bidding documents and in the Notice Inviting Tender;

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 32(A), and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

The Bid shall be opened on the same day (11-04-2016) at 1400 hours and the same venue in the presence of Bidding Committee and ending bidders who choose to be present on the occasion.
- 4/- Bid Security 2% of the total bid in the form of Pay Order in favour of the office of the Senior Superintendent of Police District Central, Karachi should be submitted with Bids.
- 5/- Only bids offered on the prescribed tender form issued by the Police Department shall be accepted. However, additional sheets may be attached, if required.
- 6/- Conditional tender / application will not be entertained.
- 7/- The Procuring Agency may reject any or all postpone date as per relevant provisions of SSP Rules 2010.
