
As per advertisement, "Competent Authority reserves the right to reject any or all the tenders without assigning any reason thereof". It is violation of Sindh Public Procurement Rules 2010, Rule No. 25. Stated as under;

25. Cancellation of Bidding Process (4) The procuring agency shall, upon request by any of the bidders, communicate to such bidder, grounds for the cancellation of bidding process, but is not required to justify such grounds;

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 32(A), and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
