Sub: Violation of Sindh Public Procurement Rules 2010. Complaint received Sindh Police for Procurement of Transport Vehicle for Sindh Police on the Tender Enquiry published in daily newspaper 'Jahan- e- Pakistan' on 11th Feb, 2017.

Dear Sir,

Transparency International Pakistan has received a complaint against Sindh Police for Procurement of Transport Vehicle for Sindh Police on the Tender Enquiry published in daily newspaper 'Jahan-e-Pakistan' on 11th Feb, 2017 from M/s Fuso Master Motors (Pvt) Ltd (Copy Enclosed).

The complainant has alleged that;

1. They received letter No. 1896-99/MT/VEH/2017 Karachi and 1904-07/MT/VEH/2017 Karachi dated 20-03-2017 wherein their technical bid were rejected without mentioning the reason for rejection.
2. During the meeting on M/s Fuso Master Motors (Pvt) Ltd's (complainant) request they were verbally informed that their offer has been technically rejected on following reason;
 - a) Manufacturing and assembling facilities is not up to the mark.
 - b) After sales and services found not satisfactory.
3. Technical evaluation marking criteria attached with the technical document does not include the points on the basis of which Fuso Master Motors (Pvt) Ltd technical offer has been rejected.
4. Moreover number obtained by Fuso Master Motors (Pvt) Ltd has not been announced at the time of opening of commercial bid where as other participating bidders marks were announced by purchase committee.

It is a violation of SPPRA 2010, Rule No. 45. Stated as under;

45. Announcement of evaluation reports - Procuring agencies shall announce the results of bid evaluation in the form of a report giving reasons for acceptance or rejection of bids. The report shall be hoisted on website of the Authority and that of the procuring agency if its website exists and intimated to all the bidders at least seven (07) days prior to the award of contract.

Since the bidder has made the complaint, the matter must be put up to the grievance committee for redressal as per SPPRA 2010, Rule No. 31(1). Stated as under;


31. Mechanism for Redressal of Grievances (1)- The procuring agency shall constitute a committee for complaint redressal comprising odd number of persons, with appropriate powers and authorizations, to address the complaints of bidders that may occur during the procurement proceedings.



IGP, Police Department is requested to kindly examine the complaint and if found genuine take necessary action against all those officers involved in corrupt.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.

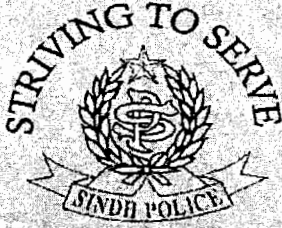

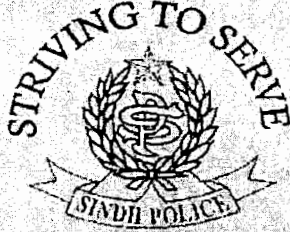
